Dr Dvir Abramovich

Dr Abramovich is the Israel Kipen Director of The Program in Jewish Culture & Society at The University of Melbourne, Australia, and Chairman of the Anti-Defamation Commission. A past President of the Australian Association for Jewish Studies, he is the author of five books, including his most recent, "Fragments of Hell: Israeli Holocaust Literature", published by Academic Studies Press in 2019.

Dr Jennifer Creese

Dr Creese is a sociocultural anthropologist whose work examines the construction of Jewish identity within Australian multiculturalism. She received her PhD from The University of Queensland, Australia, and is the author of "Jewish Life in Queensland: Celebrating 150 Years Since 1865" published by the Queensland Jewish Board of Deputies in 2016. Dr Gilead is Malka Einhorn Modern Hebrew Lecturer and Hebrew Language Program Coordinator in the Faculty of Arts and Social Sciences at The University of Sydney, Australia. She teaches and researches in the area of additional language education with particular focus on Modern Hebrew. Her current research publications cover a wide range of issues relating to the ways entry-level university students acquire Modern Hebrew.

Dr Gil Graff

Dr Graff is Executive Director of Builders of Jewish Education, Los Angeles, USA, and a specialist researcher on Jewish education. He holds a Masters Degree in Educational Administration (CSUN) as well as a J.D. (UCLA School of Law) and Ph.D. in Jewish History (UCLA). He has been a California Senate Fellow, a Jerusalem Fellow, and a Visiting Scholar at the Oxford Centre for Hebrew and Jewish Studies.

Dr Anna Hirsh

Dr Hirsh is the Senior Archivist at the Jewish Holocaust Centre, Melbourne. She holds a PhD in Jewish Studies from the University of Melbourne, and an MA in Art Curatorship. Dr Hirsh's academic interests are in Jewish Studies and Holocaust Studies, Art History and memory spaces. As well as her role at the JHC, she is an Honorary Fellow of Deakin University.

Dr Max Kaiser

Dr Kaiser is an Associate Lecturer and Tutor at The University of Melbourne, Australia, in the School of Historical and Philosophical Studies. He received his PhD in 2018 from The University of Melbourne, and is currently working on a book, based on his doctoral thesis, on Jewish antifascism in Australia in the late 1940s and early 1950s.

Dr Mühlen is undergraduate professor and collaborating professor of the professional masters degree in psychology at the University of Caxias do Sul, Brazil. He has also written a Uchronic alternate history series focused on an entirely different outcome to the Kimberley Plan: a book about Jews alongside Aboriginal people, and also about lizards, diamonds and cricket (the sport, not the insect) and a girl with a green washcloth called "Batsheva".

Dr Jan Lániček

Dr Lániček is a Senior Lecturer in modern European history at UNSW, where he has been since 2012. His specialty field is Holocaust Studies, particularly post-Holocaust reconciliation and justice in former Czechoslovakia. Dr Lanicek has strong ties to the field of Jewish Studies in the UK, holding an Honorary Fellow of the Parkes Institute for the Study of Jewish/non-Jewish Relations at the University of Southampton. Along with Ms Jennifer Creese, he is co-Editor of the Australian Journal for Jewish Studies, and Vice-President (NSW) of the Australian Association for Jewish Studies.

Dr Samantha Mitschke

Dr Mitschke is a playwright and theatre historian, specialising in British and American Holocaust theatre. Her doctoral research focused on the effects and experiences of empathy in British & American Holocaust theatre. She received her PhD from the University of Birmingham, UK in

2015, and in 2016 was AHRC Cultural Engagement Fellow at the University of Leicester. She is currently at work on a study of the rise and fall of the 'Holocaust musical'.

Ms Elizabeth Offer

Ms Offer is a graduate researcher in the History department of the School of Humanities and Social Sciences, La Trobe University. Her doctoral research focuses on the Jewish communities which formed on the Central Victorian Goldfields in the 1850s. Dr Brendan C. Walsh

Dr Walsh is a researcher at the Institute for Advanced Studies in the Humanities, within the University of Queensland, Australia. His research interests are largely concerned with the intellectual history of early modern Reformed Protestant demonology, focusing on demonic possession, exorcism, witchcraft, and matters of spiritual healing. He is currently at work on a manuscript based on his doctoral thesis, on the early modern English Puritan exorcist John Darrell and his influence on the theological and demonological discourses in this period.
