Dr Dvir Abramovich

Dr Abramovich is the Israel Kipen Director of The Program in Jewish Culture & Society at The University of Melbourne, Australia, and Chairman of the Anti-Defamation Commission. A past President of the Australian Association for Jewish Studies, he is the author of five books, including his most recent, "Fragments of Hell: Israeli Holocaust Literature", published by Academic Studies Press in 2019.

Dr Jan Láníček

Dr Láníček is a Senior Lecturer in Modern European and Jewish History at the University of New South Wales in Sydney, Australia. His recent books include Arnošt Frischer and the Jewish Politics of Early 20th-Century Europe (2017), Jews and Gentiles in Central and Eastern Europe during the Holocaust in History and Memory (edited with Hana Kubátová, 2017), and Czechs, Slovaks and the Jews, 1938-1948 (2013). He is currently completing a study of post-Holocaust judicial retribution in Czechoslovakia. Along with Dr Jennifer Creese, he is co-Editor of the Australian Journal for Jewish Studies, and Vice-President (NSW) of the Australian Association for Jewish Studies.

Dr Andy Pearce

*Dr Pearce is Associate Professor in Holocaust and History Education at University College London.
